I have recently given notice of my retirement from 30 years of government service and returned my several Commissions both to the US Congress and Social Security Administration due to declining physical health to wit:

1. **Exhibit A and B** are Fiats and Congressional Commissions being returned to the government.
2. **Exhibit C** is a digitized risk or liability report which is designed to identify areas of risk to government programs or personnel.
3. **Exhibit D** is a recent letter to Social Security officials that I will no longer be supporting their FIAT or ORDER to defend key provisions of the Social Security Act.

FEDERAL STATUTES CREATED IN THIS PROCESS

The digitized records show that between 1996 and 2016 the audits and surveys helped create Title 42 USC 13201 Homeless Act cosponsored by US Congressmen Mike Lowry (D WA) and Tom Foley (D WA); Case Management for Community Service Block Grants by US Senators Mark O Hatfield (R OR), US Senator Edward M Kennedy (D MA), and US Senator John Glenn; Food Stamps for Homeless Act by Congressman Tony Coelho (D CA) and Tom Panetta (D CA); Welfare Reform Act of 1996; USA Freedom Act of 2015 and other matters.

1. **Exhibit E:** The Rules of Congress provide that anything submitted as evidence to Congress has immunity and can not be heard in any civil or criminal court because of Separation of Powers provisions of the Constitution.
